
Meeting Notes

- 1) The meeting started at 2 pm and concluded at 3 pm.
- 2) Meeting went per script of the slide deck.
- 3) Tonmoy Dasgupta pointed to a couple of data observations on the latest PTNP, though not a cause for alarm, needed attention in future rounds of the PTNP data maintenance. Of note was 1814 NPIs who were PCPs and also some other unlikely specialty (or the other way around). This list would be shared with issuers.
- 4) The data preparation required for PY2026 was explained. The process has become simpler with 5 templates required instead of 7 in the past. No NA computation or upfront justifications was necessary.
- 5) The customized Justification Template crucial in the NA regulatory dialog from PY2026 and going forward, was demonstrated with actual data from a randomly chosen issuer.
- 6) The outlier address determination details was presented based on PY2025 data. Tonmoy Dasgupta felt that sharing the PY2025 results with issuers may be a good idea, as it would provide enough time to issuers to use it and correct their source data systems before generating their PY2026 data.
