Meeting was adjourned around 10:36 am.</li> <li>• Meeting went as per script of the slide deck.</li> <li>• The summary of the changes to the PTNP through numerous adds and deletes were presented.</li> <li>• The large number of removals based on disappearance of NPIs from the APCD was highlighted. It had the potential to shrink the large 41K classifications within the PTNP by as much as 17%. The Department was motivated to make it less burdensome to maintain the large PTNP by the APCD-based housekeeping.</li> <li>• However, the Department urged caution with APCD-based purges for various reasons <ul style="list-style-type: none"> <li>○ Novelty of the approach</li> <li>○ Lack of enough time to vet the idea from experts in both the billing and network systems.</li> <li>○ Wariness over results from the APCD</li> </ul> </li> <li>• There were no questions raised during the meeting.</li> </ul>
