 - Adequate time and notice has been given to the issuers to prepare for PTNP data maintenance
 - It is critical that data submitters closely review "Errors to avoid" during both stages of the data maintenance (Slides 27, 28 & 29). He reiterated the importance of providing brief reasons behind every addition, deletion, or objection in the voting stage.
 - AID encourages communications from issuers during the PTNP data maintenance process whether making suggestions or seeking clarifications.
- Dy. Commissioner Zane Chrisman encouraged marketplace QHP issuers to provide feedback on the CMS proposal to include Arkansas in the Network Adequacy Classification pilot project.
