




#### **Provider Type NPI Pool data** maintenance



#### **PY2018 Finalized Provider Type-NPI Pool** published



- 28% reduction in unique NPIs from 24691 in PY2017 to 17678 in PY2018.

## Improving PTNP Data Maintenance processing -1



Issuers need to

- 1) Understand the PTNP data maintenance process, and
- 2) Follow data specifications within templates


# Improving PTNP Data Maintenance processing -2



- Take advantage of the Addition-Deletion stage to correct the PTNPs. The Objection/Validation stage is not the place to make suggestions for additions, removals or classification corrections.
- The industry Objection/Validation stage is *not* about responding whether the NPI represents a valid provider. It is about responding with a consent or an objection to a suggestion of
  - Addition to a Provider Type, or
  - Removal from a Provider Type.
- In the Addition-Deletion stage a misclassified NPI may need more than one suggestion to correct
  - Suggestion to remove the NPI from the incorrect Criteria Code and if applicable
  - Suggestion to add the NPI to the correct Criteria Code(s).
- Use the correct data submission template at every stage
- Provide meaningful reasons behind
  - Addition or removal suggestions, or
  - Objecting to other issuer suggestions.
- Avoid ambiguity in responses and avoid variation for the same response. For example responding to remove suggestions in the "Issuer Response" with a text of "Remove" after a series of "Agree" responses is ambiguous.
- While adding a NPI or objecting to a removal be cognizant of
  - Practicing locations being far out of service area
  - Taxonomy



#### **PTNP data maintenance process**







### **Arkansas designed templates**



- All templates have updated instructions.
- There are some significant changes within the *PY2018 AR Specialty Access Template* 
  - Pharmacies has been added as a facility C280 "C-Bucket". Does not apply to Dental only issuers. Criteria threshold is 30 miles (36 miles for rural counties as the usual 20% relaxation applies).
  - Three Hospital types have been deemed as "Specialty" Hospitals and the distance requirement has been changed from 30 to 60 miles (72 miles for rural counties as the usual 20% relaxation applies).

Criteria ID	Category Name	Criteria Threshold (miles)
C030	Mental Health/Behavioral Health/Substance Use Disorder Facility	60
C200	Hospital by Licensure Type-Mental Health & Substance Abuse	60
C210	Hospital by Licensure Type-Rehabilitation	60

#### **PY2018 SERFF Network Adequacy Data Submission Instructions**



- Documents what issuers need to know to prepare data for Arkansas templates
- Mentions Federal templates required for the Arkansas NA Program
  - Essential Community Providers/Network Adequacy Program Template
  - Service Area Template
  - Network ID Template (This template becomes necessary in NA review if the issuer has more than one network).
- Please note the following are no longer required as all information is provided within *AR Specialty Access Template* 
  - Geo-access maps
  - PDF report of provider type access by county
